Export Controls Reform (ECR)

Brief Description:

In 2009 President Barack Obama initiated the Export Control Reform (ECR) initiative on modernize the export control system. By that time, the U.S. Munitions List administered by the Department of State and the dual-use control list administered by the Department of Commerce had not been comprehensively updated since the early 1990s in the first Bush Administration. The purpose of this comprehensive review of the export controls system is to identify possible reforms to better address current threats and to navigate the rapidly changing technological and economic landscape of the 21st century.

ECR Initial Assessment Summary:

The initial review was conducted by an interagency task force, created by the direction of President Obama, which included all applicable agencies and departments with roles in export controls, such as the Department of State, Defense, Commerce, Energy, Treasury, Justice, Homeland Security and the Office of the Director of National Intelligence. The assessment, completed in early 2010, found numerous deficiencies in the current export control system, such as a multitude of enforcement agencies with overlapping and duplicative authorities, and a number of separate information technology systems or agencies with no IT system at all that issues licenses. As a result the Administration determined that comprehensive reform of the U.S. export control system was needed in its four main areas: Single Control List, Single Primary Enforcement Coordination Agency, Single Information Technology (IT) System, and Single Licensing Agency. Based on the assessment led by the Departments of State, Defense, and Commerce, and also including representatives from other departments and agencies, these reforms will be developed in close consultation with the private sector and Congress with extensive public review and comment. The Administration's three-phase approach to deploy the new system is currently moving forward to make specific reforms which can be initiated immediately and implemented without legislation.

ECR New Proposed System:

The new proposed system for determining which items need to be controlled will be based on a three-tier model combined with a corresponding set of policies for determining when an export license is required will be implemented. This will include a "catch all" control for sanctioned end-users and destinations, proscribed entities, and proliferation, and counterterrorism end-uses. The reform process also intends to develop a Single Control List and provide the clarity needed to end jurisdictional confusion between controlled items from the USML and CCL.

ECR Completed Reforms- Consolidated Export Screening List:

The initial phase of the reform process was completed in 2010. Lists administered by the Department of State, Commerce and the Treasury were consolidated to provide a "one stop" screening list for companies during the license application process. The lists were consolidated into a common electronic format to facilitate the screening of parties to export transactions to ensure compliance with U.S. export control and sanctions regulations. ECR Three Phase Reform Process:

The export controls reform (ECR) process has a three phase review effort for implementation:

- Phase I. Develop methodology for rebuilding control lists. STATUS: Phase I completed in 2010
- **Phase II.** Apply methodology, restructuring the USML and CCL into identical tiered and positive lists, and utilize "bright line" process. **STATUS: PENDING**

- Phase III. Merge USML and CCL into one list of controlled items, which will be administered by
 a <u>single control agency</u>. STATUS: PENDING (Phase III requires completion of Phase II list review
 as well as Congressional Legislation)

ECR Timeline:
